St Ursula's Convent School- Accessibility Plan

September 2019 – July 2021

Introduction

The governors and staff of St Ursula's Convent School have high expectations for all students. St Ursula's is an inclusive Catholic School which welcomes students regardless of their level of need, ability or disability, ethnicity and socio-economic background. It is important to note, however, that we are not a specialist provision.

We expect all students who come to St Ursula's to achieve their potential and to have their achievements recognised and valued. The achievements, attitudes and well-being of all our students matter.

The Disability Discrimination Act 1995 was amended by the SEN and Disability Act 2001 and the Equality Act 2010 to include Education. The Equality Act specifies that 'schools cannot unlawfully discriminate against pupils because of sex, race, disability, religion or belief and sexual orientation.'

According to the Equality Act a person has a disability if:

- (a) He or She has a physical or mental impairment, and
- (b) The impairment has a substantial and long-term adverse effect on his or her ability to carry out normal day to day activities.

Under the Special Educational Needs and Disability (SEND) Code of Practice, 'long -term' is defined as 'a year or more' and 'substantial' is defined as 'more than minor or trivial'. The definition in cludes sensory impairments such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Schools are required to make 'reasonable adjustments' for pupils with disabilities under the Equality Act 2010, to alleviate any substantial disadvantage that a disabled pupil faces in comparison with non-disabled pupils. This can include, for example, the provision of an auxiliary aid or adjustments to premises.

Purpose of the Accessibility Plan

All schools must plan, over time, to increase access to all areas of school life for all students with disabilities. This Accessibility plan is listed as a statutory document of the DfE's guidance on statutory policies for schools. It must be reviewed every three years and approved by the governing body.

This plan shows how St Ursula's Convent School intends, over time where possible, to increase the accessibility of our school for disabled students, staff, parents/carers and visitors.

The aim is to achieve steady planned progress over three years, not to rebuild or re-equip the School.

Context

The governors and staff of St Ursula's Convent School remain committed to using our best endeavours to ensure that all our students have access to all educational provision across the school. We are further committed to challenging attitudes about disability and accessibility and to develop a culture of awareness, tolerance and inclusion.

St Ursula's Convent School has been in its current location since 1877., and as such has limitations on the adaptations posssible in relation to access rights and the feasibility of installing any lifts or adaptations to allow wheelchair access.

The school has specific evacuation procedures to assist in the emergency evacuation of people with physical disabilities.

Current range of known disabilities in St Ursula's Convent School (September 2018)

St Ursula's Convent School currently has students with a range of physical disabilities including a small number of students with mobility issues who may need physical assistance in the course of the school day.

There is one student with a hearing impairment.

We have a number of students with Sickle Cell Anaemia.

There are a significant number of students across St Ursula's who may require emergency medication as needed such as epipens.

We have a number of students with invisible disabilities such as ADHD, ASD, Speech & Language Disorders and social communication difficulties. We have increasing numbers of students with SEMH (social, emotional and mental health).

We have growing numbers of students with severe mental health issues.

There are also a number of students with moderate learning difficulties and specific learning difficulties such as Dyslexia .

Some students use specialised equipment e.g. Angled writing boards, individual laptops scanning pens. These arrangements are organised in advance and monitored by the SEND Department.

Some, but not all, of the students described above also have special educational needs.

Some of our parents and carers have similar difficulties to their children. It is important that we continue to strive to find ways to successfully work with families in order to provide a holistic package of support to best meet their needs.

Action Plan

2019 - 2022

1. Increasing Access for all students within the school curriculum and beyond

Teaching and Learning is at the heart of the school's work. Through self-evaluation and Continuous Professional Development (CPD), we aim to enhance staff knowledge, skills and understanding to promote Quality First teaching and learning for all students.

All staff have access to individual provision maps (including personalised teaching strategies) for students with additionalneeds in their teaching groups.

Students who require specialised equipment and/or resources will be catered for by teaching and support staff and the SEND department.
