Children in school will get support that is specific to their individual needs. This may all be provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the ASD Outreach Team or Sensory Service (for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language therapy (SALT) Service.

Class teacher input via good/outstanding classroom teaching.</p>	<ul style="list-style-type: none"> ● The teacher will have the highest possible expectations for your child and all pupils in their class. ● All teaching is based on building on what your child already knows, can do and can understand. ● Putting in place different ways of teaching so that your child is fully involved in learning in class. This may involve things like using more practical learning or providing different resources adapted for your child. ● Putting in place specific strategies (which may be suggested by the SENCO or staff from outside agencies) to enable your child to access the learning task. 	<p>All children in school receive this.</p>

	<p>Usually, if your child requires this high level of support they may also need specialist support in school from a professional outside the school. The school will then meet with you and other professionals involved, and decide if it would be helpful to apply for a statutory assessment, and agree any additional information and evidence that should be included from you, other involved professionals and them.</p> <ul style="list-style-type: none"> ● After the school has sent in the request to the Local Authority (with a lot of information about your child, including some from you), they will decide whether they think your child's needs (as described in the paperwork provided), seem complex enough to need a statutory assessment. If this is the case they will look at the advice submitted and ask you and any other professionals involved with your child to write a report outlining your child's needs, if this is not already included, or information is missing. If they do not think your child needs this, they will ask the school to continue with the support at SEN Support.

If this is not the case, they will ask the school to continue with the support at SEN Support and also set up a meeting in school to ensure a plan is in place to ensure your child makes as much progress as possible.</p> <ul style="list-style-type: none">● The EHC Plan or Statement (if your child still has one) will outline the number of hours of individual/small group support your child will receive from the LA and how the support should be used and what strategies must be put in place. It will also have long and short term goals for your child.● The additional adult may be used to support your child with whole class learning, run individual programmes or run small groups including your child

<p>How will we support your child with identified special needs starting at school?</p>	<ul style="list-style-type: none"> ● We will first invite you to visit the school with your child to have a look around and speak to staff. ● If other professionals are involved, a team around the child (TAC) meeting will be held to discuss your child's needs, share strategies used, and ensure provision is put in place before your child starts. ● Your child's key person may make a home visit and also visit your child if they are attending another provision. ● We may suggest adaptations to the settling in period to help your child to settle more easily. 		

<p>How can I let the school know I am concerned about my child's progress in school?</p>	<ul style="list-style-type: none">● If you have concerns about your child's progress you should speak to your child's class teacher/key worker initially.● If you are not happy that the concerns are being managed and that your child is still not making progress you should speak to the SENCO● If you are still not happy you can speak to the Head Teacher or school SEND Governor.

<p>How will the school let me know if they have any concerns about my child's learning in school?</p>	<ul style="list-style-type: none"> ● When a teacher has raised concerns about your child's progress and targeted teaching has not met the child's needs, the teacher will raise this with the SENCO. ● Schools also have meetings every term between each class teacher and a senior staff member in the school to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as expected. ● If your child is then identified as not making progress the school will make a decision about whether to monitor this or set up an intervention group and will inform you. ● If your child is still not making expected progress the school will discuss with you <ul style="list-style-type: none"> ○ Any concerns you may have ○ Discuss with you any further interventions or referrals to outside professionals to support your child's learning ○ To discuss how we could work together, to support your child at home/school.
<p>How do we ensure that the views of your child (and other children in school with SEND) are used to plan for them and for SEND within our school?</p>	<p>In creating and reviewing the Learning Profile of your child we will talk with her and ask her view about her learning and progress and what kind of support she would like to have. Also we will ask your child if she is happy with the support she receives.</p> <p>SEND pupils are involved in all activities that make up school life including pupils' council and mentoring.</p>
<p>How is extra support allocated to children and how do they move between the different levels?</p>	<ul style="list-style-type: none"> ● The school budget, received from Greenwich LA, includes money for supporting children with SEND. ● The Head Teacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of the needs of the children currently in the school. ● The Head Teacher and the SENCO discuss all the information they have about SEND in the school and decide what resources/training and support is needed taking into account the following: <ul style="list-style-type: none"> ○ the children getting extra support already ○ the children needing extra support ○ the children who have been identified as not making as much progress as would be expected. <p>All resources/training and support are reviewed regularly and changes made as needed</p>

How are the adults in school helped to work with children with a SEND and what training do they have?	<ul style="list-style-type: none"> ● The SENCO's job is to support the class teacher in planning for children with SEND ● The school has a school development plan, including identified training needs for all staff to improve the teaching and learning of children including those with SEND. This may include whole school training on SEND issues or to support identified groups of learners in school, such as ASD, dyslexia etc. ● Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with SEND. ● Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g. from the ASD Outreach service, STEPS and Sensory service or medical /health training to support staff in implementing care plans. ● Training takes place on a regular basis. If you would like to hear about the training which is currently taking place or has taken place by the staff members in the school, please speak to the Head Teacher or SENCo/ Deputy Head Teacher. 	
How will the teaching be adapted for my child with learning needs (SEN/ and or disabilities)	<ul style="list-style-type: none"> ● Class teachers plan lessons according to the specific needs of all groups of children in their class and will ensure that learning tasks are adjusted in order to enable your child to access their learning as independently as possible. ● Specially trained support staff can implement the teachers modified/adapted planning to support the needs of your child where necessary. ● Specific resources and strategies will be used to support your child individually and in groups. ● Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs and increase your child's access to what is on offer. 	

<p>How will we measure the progress of your child in school? And how will I know about this?</p>	<ul style="list-style-type: none"> ● Your child's progress is continually monitored by her class teacher. ● Her progress is reviewed formally every term and a target given in English, Maths and Science as well as progress in other areas, as appropriate, such as attendance, engagement in learning and behaviour. ● For some children with SEND a more sensitive assessment tool is used which shows their level in more detail and will also show smaller but significant steps of progress. The levels are called 'P levels'. ● The progress of children with an EHC Plan/ Statement of SEND is formally reviewed at an Annual Review with all adults involved with the child's education. ● The SENCO will also check that your child is making good progress in any individual work and in group work. ● A range of ways will be used to keep you informed, which may include: <ul style="list-style-type: none"> ○ Student Planner ○ Letters/certificates sent home ○ Additional meetings as required ○ Reports
<p>How will we make arrangements to ensure that the social emotional needs of your child are met in school?</p>	<p>A number of support systems are available to help with the social and emotional needs of your child. These include:</p> <ul style="list-style-type: none"> ● Pastoral support available ● Safeguarding and Well-Being Officers ● School Chaplaincy support ● School counsellor ● TAs

<p>How does our school make special arrangements for looked after children (LAC) with SEND?</p>	<ul style="list-style-type: none"> ● We consult with the virtual school – Head Teacher and SENCo as appropriate for personalised support as required. We also liaise with the allocated social worker, to ensure all agencies are working collaboratively to develop an appropriate support package for each child. ● We review the child’s needs and progress regularly, for example before entering the school to ensure a smooth transition from their previous setting and then at regular intervals. ● We ensure Pupil Premium is being used to effectively enable the child to meet their outcomes. ● The SENCo ensures that training and policies are supportive of looked after children with SEND. ● The Designated Governor for LAC works to ensure provision is enabling LAC with SEND to make good progress.
<p>How have we made this school physically accessible to children with SEND?</p>	<ul style="list-style-type: none"> ● We ensure that equipment used is accessible to all children regardless of their needs. ● We have a medical room. ● We have a dedicated SEN room where individual and small group interventions take place.

<p>How will we support your child when they are leaving this school? Or moving on to another class?</p>	<p>We recognise that ‘moving on’ can be difficult for a child with SEN and / or disabilities and take steps to ensure that any transition is as smooth as possible.</p> <ul style="list-style-type: none"> ● If your child is moving to another school: <ul style="list-style-type: none"> ○ We will contact the new school’s SENCO and ensure he/she knows about any special arrangements or support that need to be made for your child. ○ We will make sure that all records about your child are passed on as soon as possible.

	<ul style="list-style-type: none"> ● When moving classes in school: <ul style="list-style-type: none"> ○ Information will be passed on to the new class teacher in advance and in most cases, a planning meeting will take place with the new teacher. ● In Year 6 <ul style="list-style-type: none"> ○ The SENCO will attend the Primary Transition Day to discuss the specific needs of your child and the specialist session for students with an ASD, as appropriate. ○ Your child will attend a small group in school, to support their understanding of the changes ahead. This may include creating a 'Personal Passport' which includes information about themselves for their new school.

<p>What training did staff at our school have in SEND over the year 2019/20</p>	<p>The SENCO's job is to support the subject teachers in planning for children with SEND.</p> <ul style="list-style-type: none"> ● All teachers received training related to Thinking Hard strategies which is an intrinsic part of good quality teaching. Information on learning needs and recommendations of strategies is the first step of meeting the needs of children with special education needs. ● Teaching assistants attend training courses run by outside agencies that are relevant to the needs of specific ● children in their class e.g. from the ASD Outreach team and Online Dyslexia Training. ● The school has a school development plan, including training for all staff to improve the teaching and learning of children including those with SEND.
